### **NOTICE OF BOARD VACANCIES**

CREDCO, the economic development corporation of the Cheyenne River Sioux Tribe, is currently seeking qualified persons to fill two (2) vacancies on its Board of Directors. According to the CREDCO Charter, individuals interested in serving on the CREDCO Board of Directors must be a member of the Cheyenne River Sioux Tribe and must possess a business and/or management background. At least 3 of the 5 vacant seats will be filled with individuals who have a BS degree or higher in Business Administration or Finance. Interested persons cannot have been removed from the CREDCO Board for cause in the past. Individuals who serve on the Board cannot be simultaneously employed by IHS or BIA. Board member terms are staggered; therefore, individuals appointed to the Board of Directors will initially serve either a 3-year or a 4-year term, but subsequent terms may be served and will be for 4-year periods.
