Therefore, the Petition shall be accompanied with the following: a completed Candidate's Certification of Qualification Form (Form #1 Appendix); a receipt for payment in the amount of \$50.00 for the Background Check Fee; a receipt for payment in the amount of \$25.00 for the Drug Testing Fee; a signed copy of the Drug Testing Results and other qualifications for candidacy upon submission to the Tribal Secretary's Office. The Tribal Election Board shall certify the petitions. Note: The candidates of Officers-At-Large are required to furnish proof to the Tribal Election Board that in the event they are elected to Office, they will be able to furnish satisfactory bond.
