TO THE MEMBERS OF THE CHEYENNE RIVER SIOUX TRIBE:

**“AFFIDAVIT BALLOTS” LIST
FOR
2024 PRIMARY ELECTION**

Any candidate wishing to challenge the veracity of an affidavit submitted by any person voting by affidavit may submit a written challenge to the Election Board no later than 5:00 p.m. on the third business day (Friday, August 16, 2024) following Election Day.

On the fourth business day following Election Day (Monday, August 19, 2024) the Election Board shall hear and rule on the challenges submitted. All interested persons may be present. The rulings of the Election Board shall be final. If the Election Board rejects as fallacious, untrue, or incorrect the affidavit of any person voting by affidavit, the Board shall destroy such person’s ballot. If the Election Board approves the affidavit of a person voting by affidavit, the Board shall deposit such person’s ballot in the appropriate box.

After the Election Board hears and rules on all challenges to the affidavits submitted in accordance with subsection (3) above, and no later than 5:00 p.m. on the fifth (5th) business or working day following election day, the Election Board shall officially canvass the votes.
